1 This Court, having granted final approval of the Joint Stipulation of Class Action  
2 Settlement and Release in the above-entitled case, as set forth in the Court's Order  
3 Granting Plaintiff's (1) Motion for Final Approval of Class Action Settlement and (2)  
4 Motion for Final Approval of Attorneys' Fees, Costs, and Enhancement Award:

5 **HEREBY ENTERS JUDGMENT AS FOLLOWS:**

6 1. Pursuant to California Rules of Court, Rule 3.769(h), the Court hereby  
7 enters judgment consistent with, and as expressly set forth in, the terms in the Joint  
8 Stipulation of Class Action Settlement and Release in the above-entitled case for Plaintiff  
9 Deborah Sparks and the 1,576 Class Members identified in the Class List Defendants  
10 provided to the Kurtzman Carson Consultants, LLC on February 4, 2013, excluding the  
11 individuals identified in the attached who submitted a timely and valid Request for  
12 Exclusion Form from the Joint Stipulation of Class Action Settlement and Release, and  
13 excluding the individual who submitted a timely Claim Form that was not on the original  
14 Class List.

15 2. Kurtzman Carson Consultants, LLC shall post a copy of this signed  
16 judgment for thirty (30) calendar days on its website in compliance with California Rules

18 3. Pursuant to California Code of Civil Procedure Section 664.6 and Rule  
19 3.769(h) of the California Rules of Court, this Court reserves exclusive and continuing  
20 jurisdiction over this action, the Class Representative, members of the Class, and  
21 Defendants for the purposes of:

- 22 (a) supervising the implementation, enforcement, construction, and  
23 interpretation of the Settlement Agreement, the Preliminary  
24 Approval Order, the plan of allocation, the Final Approval Order,  
25 and the Judgment; and  
26 (b) supervising distribution of amounts paid under this Settlement.
